2. Eligibility Criteria for the candidate
  - **Basic degree in science** from a recognised University/Institution  
**OR**
  - **3 years Diploma** in Engineering from a recognised University
3. **Training Course Details:**
  - i) Duration of the Course - **15 working days (21<sup>st</sup> April to 7<sup>th</sup> May 2025)**
  - ii) The structure of the course will be as follows:

4. All candidates will have to be present in Mumbai during the training period for Lectures, Practical's, Field Training, Technical Visits and Examinations at BRIT and RP&AD respectively.
5. **Course Fees**
  - o Fresh Candidate (Full Course – IIAI Members) : Rs. 25,000/-
  - o Fresh Candidate (Full Course Non-Members) : Rs. 30,000/-
  - o Repeat Candidate (Full Course) : Rs. 12,500/-
  - o Repeat Candidates only exam at BRIT and RP&AD : Rs. 1,500/- (no training)
6. **Examination**

The examination shall consist of:

  - o Two written papers of 75 marks each (aggregating 150 marks)
  - o Objective-type questions (Paper 1 & Paper 2)
    - Correct answer : 100 % Marks
    - Wrong Answer : (-) 50 % Marks (negative marking!)
    - No Attempt : Zero Mark
  - o Evaluation on Field Training: 50 Marks
  - o 30 marks on field training and 20 Marks through interaction with candidates' i.e. evaluation during the field training
7. **Passing Criteria:**
  - o Not less than 50% each in Written and Evaluation on Field Training
  - o Not less than 60% in aggregate
8. **Re-Appearence For Examination:**
  - o There shall be at least a three-month gap between two consecutive examinations.
9. **Travel and Accommodation** expenses are to be borne and arranged individually or by the sponsoring Company/Organisation
10. **Enrollment Procedure**
  - a. Send Nomination forms (separate for each candidate) duly stamped & signed by the authorized signatory of your Company along with necessary copies of documents such as educational certificates, previous employees certificates, license copy, photos etc.
  - b. On confirmation of candidate IIAI will raise the invoice
  - c. Payment of invoice as per the bank details provided
  - d. IIAI will confirm receipt of payment and dispatch study material.
  - e. IIAI will send a reminder mail to confirm candidates a week before the start of the training course
